The Court finds the Defendant has received a copy of the Indictment, and that his true name is set forth thereon.

The Defendant has retained private counsel.

The Defendant is here on Interstate Agreement on Detainers.

Counsel for the Defendant waives the reading of the Indictment, and enters a not guilty plea on behalf of the Defendant.

**IT IS ORDERED** directing the Clerk to enter the not guilty plea of record.

**IT IS ORDERED** setting these matters for a **Case Management Hearing on Wednesday, March 19, 2008 at 8:15 a.m.**

The Court admonishes the Defendant and advises him of the disclosure process and advises him that his failure to appear at any further hearing will result in the issuance of a bench warrant.

Discussion ensues as to other cases that are pending, discovery and possible enhancement motions. The Court reads the charges, and advises the Defendant of the possible range of penalties involved. Discussion ensues as to any pending plea offer, and victim's rights, if applicable.

**IT IS ORDERED** directing the Mohave County Sheriff's Office to hold the Defendant in custody without bond pending the charges in Mohave County being resolved.

**IT IS ORDERED** amending the Minute Order to reflect charges in CR-2005-0842. The charge was in fact dismissed with prejudice, not without prejudice.

The Court recesses at 8:25 a.m.
