WE, THE NON-FLDS RESIDENTS OF SHORT CREEK, HAVE BEEN TRYING FOR NEARLY 4 YEARS TO BRING A PEACFUL END TO THE TYRANNY AND THEOCRACY OF SHORT CREEK. UNLIKE OUR FLDS NEIGHBORS WE PAID OUR TAXES, OBEYED THE COURTS ORDERS AND OBEYED THE LAW. DESPITE OUR WILLINGNESS TO DO SO MARK SHURLIFF HAS NOW CAVED IN TO POLITICAL PRESSURE AND

HAS EXCLUDED OTHER INTERESTED PARTIES FROM REPRESENTATION AT THE TALKS. WHEN AGREEMENTS COULDN'T BE REACHED OTHER ATTENDING PARTIES WERE SENT HOME WHILE THE ATTORNEY GENERAL MET PRIVATELY WITH FLDS REPRESENTATIVES IN SECRET NEGOTIATIONS.

AG SHURLIFF WE DON'T WANT TO BE REFUGEES. WE DON'T WANT TO BE FORCED OUT OF OUR HOMES AND COMMUNITY.

WE HAVE NEVER ASKED ONE FLDS FAMILY TO MOVE FROM THEIR HOME. WE RECOGNIZE AND UNDERSTAND THEIR DESIRE TO LIVE IN THEIR HOMES AND WE HAVE RECOGNIZE THEIR RIGHT TO BELIEVE THE WAY THEY CHOOSE. AG SHURLIFF - IT IS THE FLDS THAT DO NOT RECOGNIZE OUR RIGHT TO BELIEVE THE WAY IN WHICH WE CHOOSE. IT IS WE WHO ARE BEING THROWN OUT OF OUR COMMUNITY BECAUSE OF OUR BELIEFS, NOT VISA VERSA.

RELIGIOUS SEGREGATION IS ILLEGAL AND UNCONSTITUTIONAL IN THE UNITED STATES!
