GE: Who did you tell?

MJ: Actually no, I didn't tell anybody until we came up here and my friend knew that it was wrong.

GE: You didn't feel safe down there telling anybody?

MJ: Well I didn't know it was wrong so I just didn't tell anybody. He didn't tell me to tell anybody.

MJ: He just told me to touch it and I said no.

GE: So Dan your older brother wanted you to touch him?

MJ: Mm hmm.

GE: So do you know was it summer time, spring time, fall time, winter time?

MJ: No.

GE: But you know it was when you turned five did you say?

MJ: Mm hmm.

GE: So how did this take place? How did you get there with Dan?

MJ: Um, one of my moms told me and him to go to bed, and then he took me down in the basement and told me to touch him.

GE: Okay, down in the basement, was that where your bedroom was?

MJ: No it was just where they kept all the storage and stuff. Nobody was down there so he knew it would be a good place.

GE: So what did he say to you?

MJ: He just asked me if I wanted to see something and I'm like okay.

GE: And then what happened?

MJ: He just pulled down his pants and showed me his wiener.

GE: And after he did that what happened?

MJ: Then he just took me to bed so I just slept.

MJ: Yeah.

GE: Did he say anything to you at all about it?

MJ: Yeah.

GE: What's her name?

MJ: Pam.

GE: Do you know her last name?

MJ: Mitchell.

GE: And has she been talking to you about this?
